Your Plan was reviewed as: Excelling: All children are assessed to determine if they are reading on grade level. Progress monitoring and targeted intervention plans are in place.

Your Plan was reviewed as: Emerging: Goals do not clearly address student subpopulations, teachers, and/or programs and a plan is not clearly in place to meet needs.

4. Goals are being monitored for progress.

Your Plan was reviewed as: Not Evident

The school goals are written as SMART goals.

6. Considerations / Next Steps

There is no goal for subgroups and there is no plan for progress monitoring.

Your Plan was reviewed as: Progressing: Some individual student needs are addressed. Plans for subgroups are somewhat based on flexible groups and literacy data.

Your Plan was reviewed as: Progressing: Action steps are specific to literacy best practices, but additional information is needed to ensure all stakeholders are included or evidence of success is achievable.

Plan lacks details on the Tier I and Tier II curriculums.

1. There are identified opportunities for ongoing professional growth.

Your Plan was reviewed as: Progressing: PD plans are comprehensive and specific, but may be missing a component from Level 3 (Excelling), such as how to sustain PD through coaching support or a clear plan to monitor.

2. PD plans are focused on comprehensive data to ensure needs are met.

Your Plan was reviewed as: Progressing: PD considers teacher and student data to guide topics and trainings. Differentiations for teachers based on existing levels of knowledge and experience are unclear.

3. Strengths

Professional development will be provided throughout the year in a variety of settings.

4. Considerations / Next Steps

Details on who is providing the professional development, specifics of the learning experience, and how impact will be determined are not provided.

Section 5: Family Engagement

Engage families around their child's literacy development at all ages and stages.

1. Goals include plans for communication to families.

Your Plan was reviewed as: Excelling: Frequent, regular communication to families, using a variety of methods and modalities, is present in literacy plan goals and action steps.

Your Plan was reviewed as: Progressing: There are a few opportunities for families to engage in their child's literacy learning, or there is not a clear plan to monitor the effectiveness of events.

Plan lacks details on how they will determine impact and how the parents can communicate with the school.
